This table identifies the requirements and answers key questions for earning Improving Health and Health Care (IHHC/Part IV) credit for continuing certification (MOC) through the ABMS Portfolio Program<sup>™</sup>. Evidence of participation must be submitted according to the ABMS Portfolio Program meaningful participation requirements. ABMS Portfolio Program Sponsors review and approve team-based internal QI/PI and patient safety activities according to the requirements established by the ABMS Portfolio Program.
